

AMERICAN RECOVERY AND REINVESTMENT ACT OF 2009

The Alliance for Sustainable Energy LLC (hereinafter called "Alliance") has entered into Contract No. DE-AC36-08GO28308 with the Department of Energy, an agency of the U.S. Government, for the management and operation of the National Renewable Energy Laboratory (hereinafter called "NREL"). All references to "NREL" in this document shall mean the Alliance for Sustainable Energy, LLC.

Because all or part of the work effort identified in this subcontract/purchase order (hereinafter "subcontract") will be funded by the American Recovery and Reinvestment Act of 2009 (Recovery Act), NREL is required to report detailed information for 1) each subcontract over \$25,000 where the subcontractor is not an individual, and 2) the subcontractor, in the previous fiscal year, had gross income over \$300,000.
