### Section 701 Updates: Focusing on Data Quality

Section 701 of the Energy Policy Act (EPAct) of 2005 requires the use of alternative fuels in Federal dual-fueled alternative fuel vehicles (AFVs) unless the Secretary of Energy determines that an agency qualifies for a waiver. The U.S. Department of Energy (DOE) Federal Energy Management Program (FEMP) is currently working to update the Section 701 process. This current update affects waiver review in fiscal year 2011 and beyond, and will enable the process to be more focused on ensuring that waivers are granted based on the best quality data and information available.

Location entries will be validated for accuracy (e.g., ensuring that the zip code matches the city and state). Reviews will also be cross-checked with Energy Independence and Security Act (EISA) of 2007 Sections 246 and 141 data submissions, and supporting evidence will be used in waiver review. Examples of supporting evidence include instances where reviewers are aware an agency fleet has access to an alternative fuel that is not reflected in the Advanced Vehicles Data Center (AFDC) Alternative Fuel Station Locator database (e.g., they have a fueling truck). Another example of supporting evidence could be if agency vehicles are located in geographically large zip codes, and whether or not the precise location of the vehicle within that zip code would affect the waiver request. Agencies are strongly encouraged to use address and/or latitude/longitude coordinates when requesting waivers in order to receive the most accurate results.
