EPAct Section 701 Waivers

Section 701 of the Energy Policy Act (EPAct) of 2005 requires Federal agencies to use only alternative fuel in all dual-fueled vehicles, except where vehicles have received a waiver from the U.S. Department of Energy (DOE). Agencies may qualify for a waiver if the needed alternative fuel is not reasonably available (i.e., within a 5-mile or 15-minute drive) or is more expensive per gallon than gasoline.

The Section 701 waiver request data call began June 1, 2010, and FEMP has just completed the initial review of the submitted data. The table below highlights the number of requested and approved waivers in 2010 and 2011, along with the change between these two years.

Agencies should review the results, and may appeal any decision through a formal written request to FEMP. Requests should be e-mailed to Amanda Sahl at DOE at amanda.sahl@ee.doe.gov, with a CC to Ryan Daley at the National Renewable Energy Laboratory (NREL) at ryan.daley@nrel.gov. Documentation of the reason and/or justification for an appeal is required before the request can be considered.

FEMP is currently working to improve how Section 701 waiver data is made available to the public to better identify alternative fuel market opportunities for retailers near Federal fleets. This effort includes loading the data into NREL's TransAtlas tool, which will improve the usability of the data.
